#### Rohit Bhalla, MD, MPH

Senior Vice President, Clinical Affairs and Quality & Chief Clinical and Quality Officer Stamford Hospital

Dr. Rohit Bhalla is Senior Vice President, Chief Clinical and Quality Officer, Stamford Health, a not-for-profit health care system in Fairfield County, Connecticut. In this role, Dr. Bhalla is responsible for clinical policy, programs, and affairs. He also oversees organizational care management, hospital medicine, quality, patient safety, research, and other clinical programs. Prior, Dr. Bhalla served at Montefiore Medical Center for more than a decade as Chief Quality Officer. Dr. Bhalla serves on the boards of the America's Essential Hospitals Institute and the Connecticut Hospital Association, and on the Quality Council of the Connecticut State Innovation Model Program. He is Chair of the GNYHA/United Hospital Fund (UHF) Clinical Quality Fellowship Program, and he has served on programs and advisory committees for educational institutions and other health care groups. Dr. Bhalla is Associate Clinical Professor of Medicine at the Columbia University Vagelos College of Physicians and Surgeons, and Adjunct Clinical Associate Professor of Medicine at the Albert Einstein College of Medicine. He has published several papers in the areas of quality improvement (QI) and health policy, is a member of the editorial board of the American Journal of Medical Quality and has received public and private funding for research initiatives. Dr. Bhalla received his undergraduate and medical degrees from the Boston University School of Medicine's six-year BA/MD program and his Master of Public Health degree from the Mailman School of Public Health at Columbia University.
