Federal Minimum Staffing Proposal

Minimum staffing requirements proposed

- 24/7 RN on site, §483.35(b)
 - Two years after in September 2025
- Minimum nurse staffing requirement, §483.35(a)(1)(i) & ((ii)
 - 0.55 RN HPRD & 2.45 nurse aide HPRD
 - Three years after in September 2026
- 4 hardship exemption criteria: unavailable workforce, good faith effort to R&R staff, documented financial commitment to staffing, on good regulatory standing

Revise facility assessment requirements

- Documentation that meeting residents needs
- 60 days after adopted

Require State reporting

Medicaid payments spent on compensation for direct care workers and support staff, §442.43

GNYHA's Comments Addressed

- □ Acute health care workforce shortages
- Standards fail to account for interdisciplinary care teams
- Patient case-mix is not adjusted
- Lack of available funding

GNYHA strongly opposes any Federal minimum nurse staffing requirements

Proposed Requirements for Long-Term Care Facilities



24/7 RN Availability

<u>GNYHA Comment</u>: Allow SNFs to use RN telehealth supervisory and patientmonitoring technologies as an approved substitute for SNFs when an RN is not onsite

Revised Facility Assessment

GNYHA Comment: Delay implementation from 60 days after final rule publication to two years, leverage other data sources to reduce paperwork burden, and fund the costs associated with increased resources

Medicaid Institutional Payment Transparency Reporting

GNYHA Comment: Include clinical, ancillary, and support staff titles. Incorporate all-payer revenue to align with direct-care and resident-facing staff definitions and reduce reporting burden

Continuing Resolution Brings House to a Standstill

Continuing Resolution

- 45-day continuing resolution (CR) temporarily extending FY23 funding levels
 - FEMA funding
 - No cuts to providers
 - DSH cut delay until Nov. 17
 - Community Health reauthorization
- Passed with Democratic votes
- Strongly opposed by conservatives
- Passage jeopardized McCarthy's speakership and led to motion to vacate

Republicans fail to coalesce around speaker choice, leaving House in limbo









Speaker Johnson Elected



- Mike Johnson (R-LA-04), Vice Chair of the Republican Conference, House GOP's fourth nominee for Speaker
 - Served in Congress since 2016
 - Chaired the Republican Study Committee when it released its 2019 proposal to repeal the ACA
 - Called for a bipartisan debt commission to likely focus heavily on health care
- Elected on party lines: all 220 Republicans for Johnson and all 209 Democrats for Jeffries
- Staff: Dan Ziegler, pharmaceutical lobbyist, Policy Dir
- First goal: unify the Republican Conference and prevent a government shutdown on November 17

- Continuing resolution ends Nov. 17
- FY2024 appropriations standoff will continue
 - House Republicans and Senate Democrats continue to push contrasting funding bills
 - House Republicans hope to pass all 12 FY 2024 appropriations bills in regular order
- Congress must address \$106B Biden "national security" supplemental request for Ukraine & Israel aid



Shutdown Impacts on Providers

- Medicare and Medicaid payments would continue as normal
 - Processing delays possible due to staff furloughs
 - Personnel shortages could delay approvals for Medicaid State Plan Amendments
- **FEMA:** Processing delays due to staff furloughs



Debt Commission





"The consequences if we don't act now are unbearable. We have a duty to the American people to explain this to them so they understand it well," said Johnson, who as House speaker is second in line of presidential succession behind Vice President Kamala Harris. "We are going to establish a bipartisan debt commission to begin working on this crisis immediately," Johnson added.




Healthcare justice for all New Yorkers

Legislative Update

Passed Bills: Process



Legislature must deliver to Executive before January 1

- First house to pass "controls" delivery
- Governor normally "calls up" bills in batches

Governor has 10 days to sign or veto

 Not including Sundays


If Legislature adjourns, Executive gets 30 days to act

 Unlikely to happen: entering year 2 of session

Wrongful Death

- A.6698/S.6636
- Allows damages for "grief" and "anguish" in wrongful death cases
 - Currently based on earnings
- Gov. Hochul vetoed similar bill in January

- About coverage for medically fragile children (A.4135/S.1319)
- To extend Long-Term Care Ombudsman Program access to assisted living facilities (A.7199/S.6907)
- To expand the use of non-patient-specific standing orders (A.6030C/S.6886A)

Passed and not delivered bills

- To establish a 4-year nursing home demonstration project to reduce the use of temporary staffing agencies in nursing facilities and a joint labor-management workgroup to assess the impact. (A.7328/S.6897)
- To study issues impacting the continuum of caregiving in the state and report to Governor and Legislature (A.4275/S.5980)
- To establish the lesbian, gay, bisexual and transgender, and people living with HIV long-term care facility residents' bill of rights (A.372A/S.1783A)







 ATI survey letter sent out Nov. 9; survey due Nov. 27 for eligible facilities for FY 2024 program dollars
